

PROMISSORY NOTE

FOR VALUE RECEIVED, Golden Star Enterprises Ltd., a Delaware corporation with its principal place of business at 2803 Philadelphia Pike, Suite B #565, Claymont, DE 19703 (hereinafter "Borrower") acknowledges that it is indebted to The Ideal Connection Inc., a Wyoming corporation, with its principal place of business at 30 North Gould Street, Suite 5953, Sheridan, Wyoming 82801 (hereinafter "Lender") in the amount stated herein and promises to pay to the order of Lender, the principal sum of Thirty-two Thousand, Five Hundred and Seventy Five dollars and Forty Seven cents (\$33,246.72) in five equal installments of \$6,651.34 commencing on August 1, 2023, with the final payment of \$6,651.36 due and payable on December 1, 2023.

Subject to the Borrower paying all installments when due, the Promissory Note shall be interest free. Any default in payments, the Lender shall have the right to impose an interest rate of 12% per annum on the remaining principal, unless an extension or amendment to this Promissory Note has been agreed to by the Lender.

All installments, prepayments, and other payments of principal are payable to Lender at 30 North Gould Street, Suite 5953, Sheridan, Wyoming 82801, or at such other place as the Lender or holder may hereafter and from time to time designate in writing.

Any remedy of Lender or holder upon default of the Borrower shall be cumulative and not exclusive and choice of remedy shall be at the sole election of Lender or holder.

The Borrower agrees to pay all costs of collection, including reasonable attorney's fees, whether or not any suit, civil action, or other proceeding at law or in equity, is commenced.

The Borrower waives demand, presentment for payment, protest and notice of protest and nonpayment of this Promissory Note and expressly agrees to remain bound for the payment of principal, interest and other sums provided for by the terms of this Promissory Note, notwithstanding any extension or extensions of the time of, or for the payment of, said principal.

Upon the occurrence of any default, and in addition to any other right or remedy of the Lender hereunder or otherwise at law or in equity, the Borrower hereby irrevocably authorizes and empowers Lender or its legal counsel, each as the Borrower's attorney-in-fact, to appear ex parte and with notice to the Borrower to confess judgment against the Borrower for the unpaid amount of this Promissory Note. The judgment shall set forth the amount then due hereunder, plus attorney's fees and cost of suit, and to release all errors, and waive all rights of appeal. The Borrower waives the right to contest Lender's rights under this section, including without limitation the right to any stay of execution and the benefit of all exemption laws now or hereafter in effect.

No delay or omission on the part of the Lender or holder in exercising any rights shall operate as a waiver of such right. This Promissory Note shall be governed by the laws of the State of Wyoming, and each party hereto agrees to venue and jurisdiction in the federal and state courts located in Cheyenne and Casper, Wyoming.
